Ikkin Dip It Terms of Service

Ikkin Dip It specializes in applying paint and a print of automotive quality to three dimensional substrates in order to enhance a product. Ikkin Dip It strives to offer the lowest price possible while providing the highest quality product. Once the object has been processed, it WILL NOT be able to be restored to the original finish.

BILLING: Due to the custom nature of our business, there are standard items that allow for up front discounted dealer pricing. Non-standard items and non-volume work with a matte finish is billed at a maximum of \$.75 cents per square inch plus material cost.

ESTIMATES: For non-standard and volume work dealers will receive an e-mail or phone estimate for the approximate amount of time and material required to complete a job. It will be an estimate and is subject to change based on any special circumstances that may arise during processing. Warped FX will communicate any of these circumstances prior to processing.

PRODUCT DISASSEMBLY: All products, including but not limited to firearms and archery equipment, must be disassembled and cleaned prior to arrival at the Warped FX shop unless other arrangements have been made prior to shipment. This will avoid disassembly and cleaning fees. Do not under any circumstances; include ammunition in your package. Please DO NOT ship any parts that are NOT going to be customized. If requested, we have a gunsmith service available; \$100.00 includes disassembly and reassembly or most rifles. This service is not available for archery equipment.

PAYMENT: Ikkin Dip It requires payment in full upon receipt. Ikkin Dip It does not offer terms. Volume orders require a 50% down payment. Visa, MasterCard, Discover credit or debit cards, money orders and cash are accepted methods of payment. The dealer is responsible for all shipping costs to and from Ikkin Dip It.

PACKAGING: Please send all packages Federal Express or UPS when purchasing shipping. All firearms must be shipped in plain packaging. DO NOT write that there is a firearm in the package anywhere on the packaging. Retain the tracking number and email us a copy. Make sure that a copy of this order form is included inside your box. Fill it out as completely as possible, and be sure to provide desired pattern and any special instructions.

PROCESSING TIME: Our standard processing time for completion of a job is 3 weeks. Custom work completion times may vary. You will be contacted regarding expected completion dates. Please refrain from making inquiries relating to product status before this time period. Warped FX contacts dealers the day their project is complete to collect credit card payment before return shipping product. If pre-payment has been made, we will inform dealers of completion when their product ships or can be picked up.

EXPEDITED SERVICE : It is rare that a product can be processed earlier than the standard three weeks due to pain
cure times. Requests for expedited service are subject to additional fees that will be determined on a case by cas
basis.
